Presidential Scholarship

The Presidential Scholarship is offered to students who complete high school in May or June prior to enrolling into Bethune-Cookman University in the subsequent Fall semester. The award covers **university expenses** (full-time tuition, room, board, and \$500 per semester book scholarship) not covered by federal and/or state financial aid and other non-institutional scholarships. Students must earn and maintain a 3.5 cumulative grade point average to renew the award. Awards may be renewed for a maximum of 3 years of study.

To qualify, candidates must meet these minimum academic criteria:

Cumulative GPA: 3.75

Test Scores:

SAT 1240 OR ACT 26

Enrollment Fee (Non-Refundable) Copy of Social Security Card

Disclaimer: Limited presidential and excelsior scholarships available. Students must pay an enrollment fee and complete a FAFSA application annually. Some residential facilities may require an additional fee not covered by the scholarship.

ALL SCHOLARSHIPS ARE NON-REFUNDABLE



Excelsior Level 1

The Excelsior Scholarship is offered to students who will complete high school in May or June prior to enrolling into B-CU in the subsequent Fall Semester. The award is **valued at the cost of full tuition annually**. Students must earn and maintain a 3.3 cumulative grade point average to renew this scholarship. Awards may be renewed for a maximum of 2 years of study.

To qualify, candidates must meet these minimum academic criteria:

Cumulative GPA: 3.5

Test Scores:

SAT 1130 OR ACT 23

Enrollment Fee (Non-Refundable) Copy of Social Security Card

The Excelsior Scholarship is offered to students who will complete high school in May or June prior to enrolling into B-CU in the subsequent Fall Semester. This scholarship, **valued at \$8,000**, is awarded annually. Students must earn and maintain a 3.0 cumulative grade point average to renew this scholarship. Awards may be renewed for a maximum of 2 years of study.

To qualify, candidates must meet these minimum academic criteria:

Cumulative GPA: 3.25

Test Scores:

SAT 1020 OR ACT 20

Enrollment Fee (Non-Refundable) Copy of Social Security Card

PRIORITY SCHOLARSHIP ENROLLMENT FEE DEADLINE: FEBRUARY 1, 2019

Excelsior Transfers

Students must enroll full-time. The academic excelsior scholarship for new transfer students is a onetime offer of **\$8,000** for 1 year only.

To qualify, candidates must meet these minimum academic qualifiers:

Cumulative College GPA: 3.25 w/ 28 transferable credits

Enrollment Fee (Non-Refundable) Copy of Social Security Card



Wildcat Grant Level 1 (this is a one-time offer)

The Wildcat Grant Scholarship is offered to students who will complete high school in May or June prior to enrolling into B-CU in the subsequent Fall Semester. This scholarship valued at **\$4,000**, is a onetime offer which covers university expenses for 1 year only.

To qualify, candidates must meet these minimum academic criteria:

Cumulative 3.00 GPA

Test scores: SAT 940 or ACT 18

Enrollment Fee (Non-Refundable) Copy of Social Security Card
